REIMBURSEMENT OF AIRFARE (ECONOMY CLASS)

Upon approval under the MAI Scheme by the Department of Commerce, the participants will be eligible for reimbursement of airfare (Economy Class) as per guidelines.

- As per MAI Guidelines, Partner/Director/Proprietor/Regular Officer on Senior Managerial Position of participating firm/co. (with exports FOB value between Rs.50 lakhs to Rs. 50 Crores in preceding financial year) is eligible for reimbursement of actual airfare (economy class) upto a maximum ceiling of Rs.90,000/-.
- Participating companies must have completed 12 months of membership with EPC/FIEO
- As per MAI guidelines, a company/firm can avail subsidy for maximum three MAI events in the same financial year either from FIEO/any EPC/grantee organizations and upto a maximum of three times (including past cases) for a particular event thereafter have to participate in that fair on their own.
- Claim forms duly filled and complete in all respects must be submitted to the EPC within 45 days of return to India
